Access Mental Health Services for Children with Disabilities on Maryland Medicaid or MCHP

THE LAW

Federal and State law require that children (up to age 21) who receive Medical Assistance including Medicaid, MCHP, and children in Medicaid Waivers – receive early and periodic screening, diagnosis, and treatment (EPSDT). EPSDT means that children have a right to receive periodic healthy kid check-ups, including screening for mental health needs. If the professional who does the check-up, or any other professional, finds that a service is medically necessary, the child has a right to that treatment.

How can my child access mental health services?

If your child needs an evaluation or treatment, make an appointment with a psychiatrist or therapist who accepts Medicaid. If you need help finding one, call ValueOptions at 1-800-888-1965, or call your Core Service Agency.

If your child needs any other mental health service, ask his/ her psychiatrist or therapist to make a referral to ValueOptions. They can identify a provider to deliver the service if you do not choose one.

In an emergency or crisis, take your child to the nearest emergency room and call your child's psychiatrist or therapist.

How soon should my child receive the services?

Federal law requires that services be provided with "reasonable promptness." Under Maryland regulations, services should be provided as soon as clinically appropriate if urgent, and within thirty (30) days if not urgent.

What are my child's rights under Medicaid law?

- The State or ValueOptions should not put children on waitlists for services.
- Services should be available throughout the State.
- The State should ensure that providers are available.
- Families should have the freedom to choose their provider.
- Families can change providers at any time.
- There should not be caps on the length of services provided.
- Service denials and delays can be appealed.

What should I do if my child has trouble getting these mental health services?
